Quakertown Christian Preschool Extended Care Program Enrollment Form

We will offer **Extended Care** for enrolled preschoolers between the hours of 7:30 AM and 5:30 PM, if we find there is a need. There are four different time slots that are available for this service: before class begins, during AM class time, and after morning class time hours. After your input, we will then determine what Extended Care hours we will provide. During the summer you will be notified of the specific hours for the program.

Payment and Fees

Two payment plans are available for the extended care program.

Option 1: A \$5 per hour per child fee billed at the end of each month. Each month's bill must be paid within 15 days of the previous month.

Option 2: A weekly rate of \$100 per week per child. If this option is selected, the fee will be included with the monthly tuition payment and a contract will be signed.
